<sup>5</sup> "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;

<p><b><u>Corporate tenancies</u></b></p> <p>Any tenancy where (to your knowledge)—  (a) the landlord is the Council ; and  (b) the tenant is a body in which you or your partner has a beneficial interest.</p>	<p>N/A</p>
<p><b><u>Securities</u></b></p> <p>Any beneficial interest in securities<sup>6</sup> of a body where—  (a) that body (to your knowledge) has a place of business or land in the area of the Council ; and  (b) either—</p> <p>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>	<p>N/A</p>
