# **Purpose of the Report**



## **Meetings**

Any ASB issues/concerns please raise via the Office Manager. Operational meetings continue fortnightly, Tactical meetings have been split into the current priorities – River Safety, ASB & Youth.

#### **Incidents**

The below shows the ASB incidents recorded July – September 2023:



Compared to the last month, there has been a decrease in issues.

#### Theft of Items Returned

During July – September – approximately £10,000 worth of items have been stolen stores.

#### **PSPO**

Shropshire Council adopted the variations to the <u>PSPO</u> with implementation from 1<sup>st</sup> August 2023 for a further 3 years. Shropshire Council have agreed that PSPO notices can be served by trained Prosecure staff. Training will be arranged prior to commencing.

#### **Financial Assistance**

If you're struggling with the cost of living, you may be able to apply for some help from Shropshire Council. The Council's Welfare Support Team administers Local Welfare Provision schemes that can provide support for people who are struggling to meet their essential living costs.

If you apply, we will need you to provide the most recent bank statement that you have received for each account held by you (and your partner if you have one). We will need to see this for current accounts, savings accounts, joint accounts, and for accounts that have a zero balance or are overdrawn. We may also ask you to provide this for other adult residents in the house. Each statement must cover a whole month. If you don't have the most recent statement, please go to your branch and ask them for a bank transaction statement for a whole month up to the current date. The statement should show your name and address, and have three columns showing all money received, all money spent and the balance.

#### Youth

#### STC - Update

- Stay Safe Event 18<sup>th</sup> May, Quarry. All partners will be invited to attend the event. Funding has been sought through the Thriving Children's Fund.
- Stay Safe leaflet produced covering safety aspects, including rail tracks, river safety and drugs/alcohol. Leaflets will be distributed to Schools / Colleges and venues close to the river.
- Youth Council being created, allowing young people to have a voice and get involved in local democracy. Young people from Schools and Colleges will have the opportunity to take part. Funding was obtained from the Thriving Childrens Fund.
- Knife Angel (statue made out of knifes/weapons) being considered for the Town, which will incorporate education into the Schools / Colleges.

### **SC Youth**

- SS4 detached work will continue in Town until the end of March, however when Town is quiet, patrols will be extended out into other locations which are experiencing issues.
- Sundorne initiative team have been working with a group of young people, who have been trialling Martial Arts. They are now trying football.

- Meole following engagement with young people. The Meet Place will be opening once per week providing hot drinks. Detach work takes place in Meole and Sundorne twice per week.
- National Youth Association have announced that it is the Local Authorities Statutory Duty to provide a
  sufficient youth service across the County. Needs assessment for the whole of Shropshire is taking
  place focusing on 14 17-year-olds, looking at what is available at the various locations, i.e.
  spaces/activities within the Town & Parish Councils and what the young people want.
- Participation survey for young people will be taking place obtaining young people's views and needs to form a community profile.
