## 17/23 MINUTES OF THE LAST MEETING

It was agreed that the minutes of the last meeting held on 20 July 2023 were a true and accurate record.

# 18/23 MATTERS ARISING

All matters were to be dealt with under the existing agenda.

# 19/23 BATHING WATER STATUS

The Group had agreed various actions to facilitate an application for Bathing Water Status. A progress update was provided:

- (i) Local Authority Permission the Town Clerk had spoken to Mark Barrow (Executive Director of Place) who had agreed to provide and in principle agreement in writing to Alison. It was not known whether that had been received.
- (ii) Land Owner Permissions the Town Clerk had sent the details of locations to the Head of Estates. She had not received any approvals for those sites. All Town

Council locations were acceptable. In the case of the Canoe Ramp in the Quarry, she had contacted Shrewsbury Canoe Hire to check that occasional use by swimmers did not impact on his Concession in the Quarry.

- (iii) Consultation A questionnaire had been prepared and had gone live with links put on the Council's social media and on the website. 241 responses had been received from a variety of users. Closing date was the 24<sup>th</sup> of September.
- (iv) **Stakeholder consultation** The group discussed wider stakeholders to consult with; these included:

- (v) **Social Media & Website** Staff had set up a page on the Town Council's website and had buffered a number of posts on the Council's social media accounts.
- (vi) Water Testing It was understood that the Shrewsbury Town Fisheries was undertaking testing but it was not known whether it was in the chosen locations for the Bathing Water Status application. Gareth advised that it wasn't necessary to undertake water testing as a criteria for applying for Bathing Water Status.
- (vii) Application Process It was not known how the application form completion was progressing as Alison was doing this supported by Kirsty.

# 20/23 SEVEN TRENT UPDATE

Gareth updated the group on work of Severn Trent. A press release had recently gone out advising of an £11m investment project at 6 sewage treatment works including Monkmoor. This would make sure that it could meet the increased requirements around phosphate level permits. A discussion ensued around pharmaceuticals and forever chemicals which were difficult to remove from sewage.
