121/23 GREENFIELDS RECREATION GROUND

Members considered the report of the Deputy Town Clerk & Head of Resources in relation to a settlement agreement between the Town Council and CSE for the repurchase of land at Greenfields Recreation Ground.

The final settlement fee was within the agreed set aside sum agreed by Council in December 2023. Within the Settlement Agreement there was a mutually agreed public statement. The Deputy Town Clerk was currently working on a list of FAQs to provide more detail, without compromising the principles of the mutually agreed statement.

The Head of Resources had sought guidance from HMRC on the likely Stamp Duty Fees payable.

Members were also keen that the land returns to public use as quickly as possible and that officers when possible should review all necessary works to the site to create public access. It was however noted that this parcel of land would not be treat any differently to other parcels of land.

Members also considered an update on potential proceedings to mitigate against the settlement sum. The Council's Solicitor had recommended opinion be sought by Counsel to determine the way forward. This process was agreed with further decisions being taken by Full Council in due course.

Further discussions ensued on communications in relation to the agreement.

RESOLVED:

- (i) That the Town Council makes a settlement agreement with CSE Developments Ltd
- (ii) That the Group Leaders be authorised to sign all necessary legal documentation;
- (iii) That Officers, in conjunction with the Group Leaders proceed to seek further legal advice in relation to the potential of mitigating settlement agreement costs; this to be reported back to Full Council

This resolution was agreed unanimously.
