Q4 Briefly describe your organisation.

Describe your organisation, including how many members/users you have, whether there is a subscription fee and the usual activities/services you provide. If you are a new organisation, describe the services/activities you plan to provide.

The Shrewsbury Summer Season Ltd was established in 2011, by a group of business people and arts workers, taking forward the promotion of cultural events in the town over the summer months. This was done through the production of a very popular annual guide covering local arts events, together with setting up an events website. Additionally, we promoted and managed our own events.

Following the introduction of a Shrewsbury event calendar by Shrewsbury BID, Shrewsbury Summer Season concentrated on the promotion of plays in the Castle grounds. We are very proud that we achieved 15 years of bringing Shakespeare to the Castle. In 2020 we made the decision to hand over this activity to Theatre Severn as Covid restrictions and safety could be better managed by Shropshire Council. This has proved to be highly successful, with the Council achieving multiple bookings in the grounds of the Castle last year.

The SSS company has been dormant through the pandemic years, waiting for the right event to begin supporting the cultural life of the town again.

2023 marks the 350th anniversary of birth of The Shrewsbury Dancing Master, John Weaver whose productions displayed the roots of English Ballet and Pantomime. He is known as the Father of Pantomime and English ballet. Our intention is to organise a festival in Shrewsbury in the summer of 2023 to properly recognise, for the first time, this famous son of our town.

We have begun planning some events. We are conscious of John Weaver's wider influence and connections and are building up contacts with national organisations we will work with, to enhance the events and exhibitions that we plan for Shrewsbury. We are also in talks with local organisations to work collaboratively with them, keen for them to theme their 2023 activities to align with this festival.

We intend this to be a widely publicized programme, with appeal to locals and visitors. John Weaver's history adds significantly to the town's cultural heritage and this will attract new

visitors to the town.

We want to start publicity this year, to build up a following and an anticipation of what will be an important part of Shrewsbury's cultural life and visitor offer during 2023. To do this we wish to produce a leaflet and website to begin promotion and are looking at co-funding for this initial project.

i. Try to be specific about what you will do and how you will do it.

2023, marks the 350th anniversary of The Shrewsbury Dancing Master, John Weaver. He is known as the Father of English Pantomime and English ballet.

We have begun planning some events for this significant anniversary. The focus of our plans is to inform visitors and locals of the achievements of this famous son of the town. We wish to produce a leaflet and website detailing John Weaver's life and times. This will be an important source of information, which can be used after the 2023 festival, to promote the town's cultural heritage. It can be adopted as part of the town's visitor information library.

The leaflet and website will provide a history of the local connections to John Weaver. His birthplace in the town is not known but we do know that he was baptised at Holy Cross 21st July 1673. We also know that his father was a well-established Dancing Master in the town and that he attended Shrewsbury School. He married twice and all twelve of his children were baptised in all four of the town's Parish churches, meaning that he lived in various establishments across the town. He travelled to work in London and became a well-established dance and theatrical producer. He returned to Shrewsbury and became a well published writer and an established gentleman of the town.

The research work will take time this year and there will costs for copies archive material, including sourcing documents to prepare a comprehensive town map of the places connected to John Weaver. It is well known that Shrewsbury between 1680 – 1780 was one the top 20 destinations for its luxury and leisure offer. The market town grew in the Georgian period and the local dancing masters were fashionable and well respected.

We know that following John Weaver's success in London's Drury Lane Theatre in 1717, he returned to Shrewsbury and produced shows in The Market Hall in the Square.

Online information on John Weaver will become part of Shrewsbury's history with links to the importance of his life and works.

We would also like to commission and produce as lasting commemorative installation in the grounds of Old St Chad's. We know from records that he was buried in the south aisle.

There a small brass name plate fixed to the wall inside Old St Chad's Lady Chapel, it is not publicly visible. (photo included). We would like to commission a commemorative installation for public reference. The work will take the form of a carved stonework in keeping with the ancient site.

ii. Please state how you have identified this need and how the project will benefit the people of Shrewsbury, together with the estimated time span. If you are seeking

continuation funding for this project, please provide evidence for this continued need.

As a Town Guide, a casual Visitor Information assistant and a lead ambassador for Shrewsbury BID I interact with visitors and residents. Shrewsbury has a rich heritage and visitors love making connections with history. Visitor numbers are on the increase in the town and county and the tourist offer is building our economy.

The love of 'dance' has a huge following from young dancers, professionals and Strictly fans. Residents are also showing huge interest in the rich history of Shrewsbury.

Providing an information leaflet on the 'Shréwsbury Dancing Master' 1673 - 1760, will increase visitors to the area. This in turn that will raise the profile of the ancient site of Old St Chad's. It is the second highest point in the town which is why the old St Chad's church was built on the site.

Sales of the leaflet will inform us of an initial success of the popularity and interest in the project.

Additionally, through our website and other online activity, we will ask people interested in this project to sign up for email updates and can evaluate this interest.

There will be social media pages with data that can be reviewed, and which will retain feedback and comments.

The installation will attract attention, which can be monitored through comments and local observation.

Visitors to events in the town will have purchased tickets or signed up to attend, meaning numbers will be known.

There is an interest from residents and visitors is discovering more about local famous people. Shrewsbury can now boast to have yet another important figure in history.

Maggie's current work as stated above, Town Guide, Visitor Information assistant and Lead Ambassador has provided her with an insight to public demand and interest in Heritage. Walking trials and leaflets of the Town are extremely popular with sales in the 1,000's per year.

In the past Shrewsbury Summer Season has organised multiple events, brochures and celebrate the Town's Heritage. Maggie was a director with the Shrewsbury Heritage group that produced the following festivals: Medieval Weekend, Tudor Weekend, Shakespeare Day, Darwin Days and Shropshire Olympian Festival.

The leaflet will educate and energize people about the 350th anniversary of this important Dancing Master from Shrewsbury. Support and help toward the costs of producing the leaflet would be greatly appreciated at this stage.

The commemorative installation in Old St Chad's requires consultation and discussion with the Town council directly as the grounds are cared for by the grounds staff. We are also aware that a consultation with the diocese needs to take place.

If full funding is not available then we will need to hold back on the plans for the commemorative installation because it is more important, at this stage, to proceed with work towards the 2023 festival through the leaflet and website.
