## COMMONS ACT 2006 – SECTION 15(1)

### Notice of application for registration of land as a town or village green

To every reputed owner, lessee, tenant or occupier of any part of the land below, and to all others whom it may concern.

Application (VG (A) 95) has been made to the registration authority, Shropshire Council of The Shirehall, Abbey Foregate, Shrewsbury Shropshire SY2 6ND by Dr P Day of 22 Falstaff Street, Shrewsbury and Mr M Banner of 40 Glendower Court, Shrewsbury under Section 15(1) of The Commons Act 2006, and in accordance with the Commons (Registration of Town and Village Greens) (Interim Arrangements) (England) Regulations 2007. The application seeks the inclusion of the land described in the Schedule below, which it is claimed to have qualified for registration as a Town or Village Green on 3 May 2018 by virtue of the use of the land as of right for more than 20 years for lawful recreation and pastimes.

Any person wishing to object to the registration of the land as a town or village green should send a statement of the facts on which the objection is based to Shropshire County Council of The Shirehall, Abbey Foregate, Shrewsbury Shropshire SY2 6ND on or before 1 March 2018. Any representations that are to be taken into account by the Authority in reaching a decision on the application cannot be treated as confidential and will be copied to the applicant for comment and may be disclosed to other interested parties.

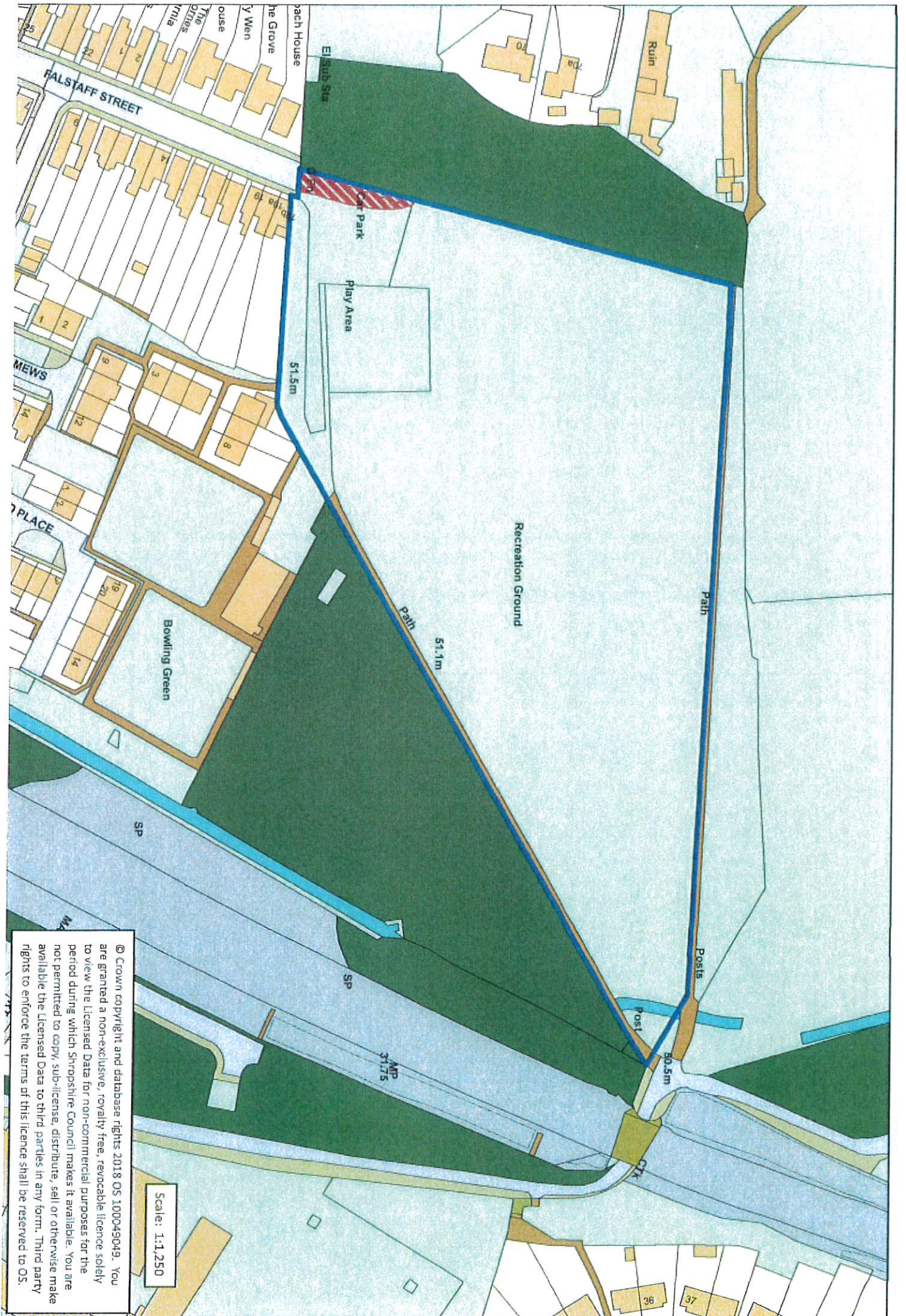
