

**SHROPSHIRE COUNCIL
(OFF-STREET PARKING PLACES) ORDER 2011
(AMENDMENT NO. 2) ORDER 2018**

Shropshire Council (hereinafter called “the Council”) in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended (“the 1984 Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order:

1. This order shall come into operation on 19 November 2018 and may be cited as the Shropshire Council (Off-Street Parking Places) Order 2011 (Amendment No. 2) Order 2018.
2. The Shropshire Council (Off-Street Parking Places) Order 2011 is hereby amended by:
 - a) Provision for market trader permits will be added to the order via the following amendments:
 - i) The creation of a new Schedule 7A as set out below:

“THE SHROPSHIRE COUNCIL (OFF STREET PARKING PLACES) ORDER 2011 – SCHEDULE 7A - OFF-STREET PARKING PLACES, PERMITS FOR MARKET TRADERS - ENTITLEMENT

Parking permits for market traders will be available for use in the designated parking areas in Galdeford B, Smithfield, and Castle Street car parks in Ludlow. The charges will be as follows:

Galdeford B and Smithfield		£2	Unlimited
Castle Street	(April to December)	£4	20

- ii) In the table in Schedule 1, the following will be added to Column 11 - Special Conditions (if any) in the row referring to Castle Street car park, Ludlow:

“Permit entitlement as Specified in Schedule 7A”;

iii) In the table in Schedule 1, the following will be added to Column 11 - Special Conditions (if any) in the rows referring to Galdeford B, and Smithfield car parks, Ludlow:

“Resident and Season Permits entitlement as Specified in Schedules 6, 7 and 7A”.

- b) The addition to its Schedules, in the relevant places, of the references in the tables in the Schedule to this order;
- c) All references to Ludlow car parks are deleted from Schedules 8 and 9;
- d) The entry relating to the St Julian’s Friars car park in Schedule 7 is hereby amended to read:

3. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.

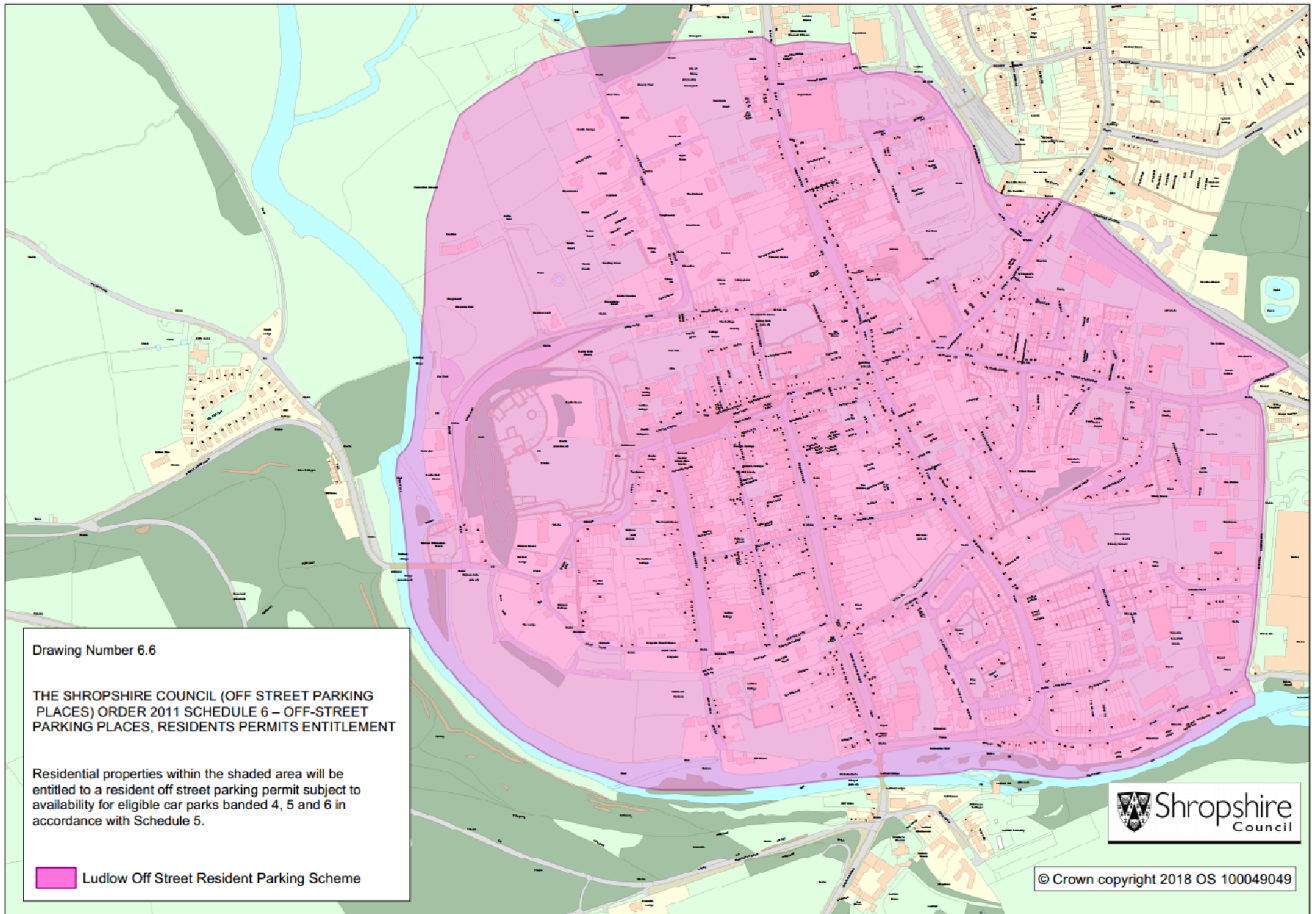
