

**THE SHROPSHIRE COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2009 (VARIOUS ROADS IN BRIDGNORTH,
ELLESMERE, LUDLOW AND SHREWSBURY) (AMENDMENT) ORDER**

Shropshire Council proposes to make the following changes to various on-street parking restrictions in Bridgnorth, Ellesmere, Ludlow, and Shrewsbury as follows:

1. The provision for the proprietor or manager of a Hotel, Guest House, Bed & Breakfast, Self-Catering or Holiday Let establishment in Low Town, Bridgnorth to buy on-street visitor permits for their guests, will be stopped;
2. The charge for parking in the Pay & Display bays in Shrewsbury will be £2.40 per hour;
3. All maximum and minimum stay, and No Return restrictions, will be removed from the Pay & Display bays in Shrewsbury;
4. The charge for parking in the Pay & Display bays on Mereside in Ellesmere will be £1.00 per hour between 8am-6pm daily. The “maximum stay two hours, no return for two hours”, restriction will be removed;
5. Changes are being made to the residents parking restrictions in the Red Zone and the Blue Area in Ludlow as follows:
 - a. Residents will be eligible for one permit per premise, with one car registration allowed per permit. The fee for purchasing a permit will be £100 per annum;
 - b. Each property shall be entitled to receive a maximum allocation of up to 200 hours of visitors parking per annum;
 - c. There will be no fee for the allocation of visitors parking for residents who purchase a residents parking permit. The charge for the allocation of visitors parking for residents of properties who do not purchase a residents parking permit will be £5 per annum.

Full details of these proposals are in the deposited documents which may be examined during usual office opening hours at The Shirehall, Abbey Foregate, Shrewsbury, or at the Customer Service Point at Bridgnorth Library, Listley Street, Bridgnorth, or at Ellesmere Library, Fullwood House, Victoria Street, Ellesmere, or at Ludlow Library, 7/9 Parkway, Ludlow.
