

NOTICE IS HEREBY GIVEN that the Shropshire Council of the Shirehall, Abbey Foregate, Shrewsbury, Shropshire, SY2 6ND intends to apply to Shropshire Magistrates sitting at Telford Magistrates Court, Telford Square, Malinsgate, Telford, Shropshire, TF3 4HX on Thursday 30th November 2017 at 10:00 a.m. for an Order under Section 116 Highways Act 1980 authorising the stopping up of a part of the highway at Somerby Drive, Shrewsbury, Shropshire in the following manner:

By stopping up an area of land being approximately 18.48 metres at its maximum length and 11.95 metres at its maximum width as shown coloured pink on the plan and being made up of tarmac on the grounds that that part of the highway is unnecessary for public use.

A copy of this Notice and plan may be inspected free of charge during normal office hours at the Shirehall, Abbey Foregate, Shrewsbury SY2 6ND.

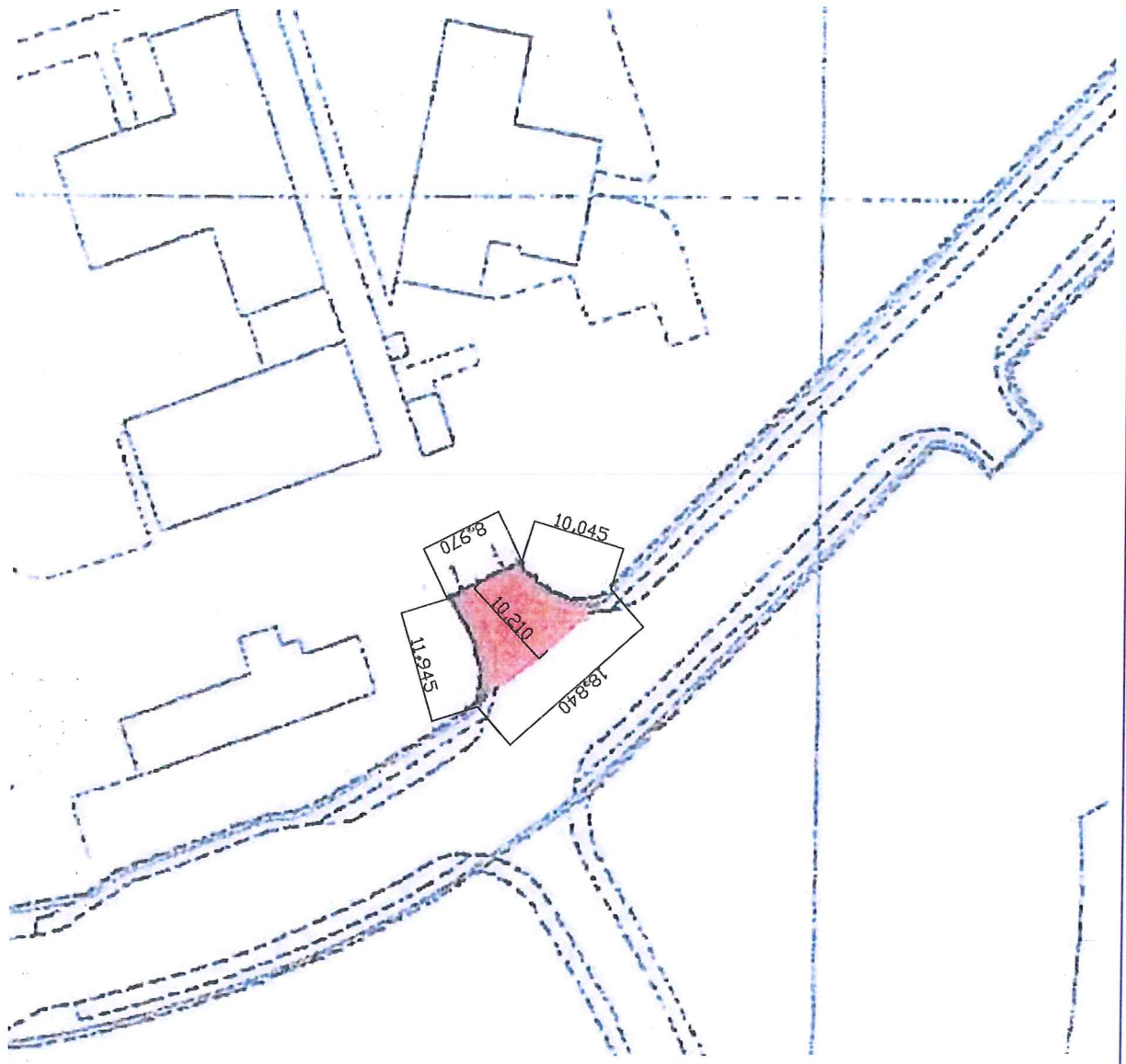
