...Shropshire Supports Refugees Has been supporting the refugees who have come to live in Shropshire since last august. I was originally asked to set up a welcome group for the refugees coming to live in Shrewsbury, and I jumped at the chance to help.

I held clothes collections, toys for the children, and household goods. We held fund raisers and bought the families Tv's kitchen appliances and various items that they requested.

I organised a xmas party to welcome all the refugees in the county and their supporting staff and volunteers, and provided all the families with welcome to Shropshire hampers full of local goods.

The face book group has been a central point for any Shropshire residents to channel help, items, and support towards the Syrian refugees, and likewise, the refugees have used it to request specific things and ask for assistance.

There are 552 people in the Facebook group, approx. 30 active volunteers who visit the families regularly to help them learn and practice English, and another 15 soon.

I was very proud to receive a Mayors award for the work we have done with the refugees, and I've got used to being on the radio since it began!

The group evidence of the generous spirit of Shrewsbury residents, and how kindness often just needs coordinating in order to be actualised.

For the organisation to continue and to be able to apply for grants, it has very recently been turned into a Not for profit Community Interest Company. The future will involve fund raising through events and applying for grants, to continue to support the refugees here emotionally, and practically with education, integration, and awareness raising activities which will involve engaging our two communities and bringing them together and a whole host of other supportive activities such as training courses for the adults, and activities and groups through the school holidays for the children

Up until now, it has all been through public donations from people who live in Shropshire and fund-raising events. Now that It is a CIC, we will be able to apply for grants from various sources, the council hopefully, being one. I will continue to put on fund and awareness raising events which will hopefully bring in some money

- i) Try to be specific about what you will do and how you will do it.

After great success with 3 big fundraisers in 2016 I have a number of events and activities planned for the rest of the year, they will be funded by donations, fundraisers and hopefully this grant.

The key event I would like this grant to help with is to assist with concert I am holding a to raise awareness in November. The aim of the concert is to get local artists and musicians, poets and performers to create a piece of work based on the migrant crisis, and as a flip side, celebrating the arrival of new cultures to our town.

I have enough artists who are keen to get involved, and some very helpful contacts willing to assist me to put it on.

It will include a week-long exhibition of local art based on the subject and potentially some workshops. Im in discussions with Flix in the sticks and Arts Alive to put on some independent films on throughout the week about the crisis in Syria.

There is a strong feeling amongst the arts world that the media has gone quiet on reporting the reality for the 65 million displaced humans around the world. They are keen and so am I, to shine a light on the issue, and to Shrewsbury residents on how they can help refugees.

It will be a very clear message that many people in Shrewsbury care and want to assist during this crisis. I will need money for this event to cover costs to include the following:

venues and hire costs, artists, musicians, films, production, exhibition and workshops and a concert as a finale. As you can appreciate this will incur considerable costs exceeding £4000 and match funding in my fundraisers prior to this event will need to exceed £2000 to ensure it can go ahead. My work is voluntary and is not included in this costing.

There are other projects that I will be instigating throughout the year, but this obviously comes down to funding. These are as follows

- a) I am putting on a xmas party again which will incur costs too. Last time there were 200 people there, and I paid for it through a fundraiser. This yr. it will be bigger and better, and very much carry a message of 'Thank you' to Refugee Action for coming to the county and doing such a good job of resettling the families.
- b) 1 activity session a week for refugee children and their families

  The summer holidays are coming, and the families here in Shrewsbury would be very grateful for a weekly event that entertains the children. I plan to organise a weekly activity, maybe a picnic and sports in the quarry, Art and crafts in a venue somewhere central, a trip to a children's attraction in the county like Park Hall, or Attingham park. A music and dance based activity would be nice, and I have a lot of other ideas. I also have a lot of offers from organisations and individuals who are qualified and experienced in all these areas. Venues are keen to participate and use their own grant and pots of money to encourage integration and cultural awareness.
- c) English lessons and English practice for the adults I support 3 off shoot groups that have arisen from my group- a craft group for Syrian and British women, an English class to be held in the

evenings to compliment the lessons they are getting already, but im hoping to hold these through the holidays when all others stop.

These require money for materials and refreshments, the bike project runs without money at the moment, and hopefully that will continue to be the case.

All my activities will be open to British families too, and will have qualified English teachers working on them. A vital continuation of their English practice through the summer holidays.

...The need for the group and the coordinating and networking became evident the minute people new there were Syrians coming to Shrewsbury.

I was inundated with offers of goods, thing, money and hands on help.

My role has been to coordinate all these offers, which continue to come in, and also liaise with the families on a regular basis to ask them how they are getting on and what they need. I realised there were things that they wanted or needed that I could source for them through the group. English practice, neighbourly help, lifts to places, someone to accompany them, show them around, introduce them to friends.

The people of Shrewsbury need a group like this because it's very people led and one day (December 2017) Refugee action will be gone. It's the community coming together and welcoming these unfortunate people. Its Shrewsbury showing its generous caring and concerned about people from anywhere who need help. It's a group of people to be proud of, and when we feel we

have done everything we can to give them a leg up and showed them the best of Shrewsbury, the group will close down or change shape, and the refugees can go about their business living happy, successful lives in our beautiful county.

I would like Shropshire Supports Refugees to be a source of education and support for both the Syrian and British people of Shrewsbury, channelling voluntary support and nurturing independence and success in our Refugee friends. All my activities and events are inclusive refugees or asylum seekers who are in Shrewsbury and Shropshire from any area of the world.

I will be seeking continued funding from as many sources as possible. This is because I have a wide and varied programme of events planned, and I can no longer do all this for no money and with no time set aside to concentrate on it.

If I am to be able to continue to support the refugees into the future, I need to be able to focus on the projects with the respect they are due, do things formally and correctly, and potentially create a part time role out of it.

iii) How many people from the Parish of Shrewsbury do you expect to benefit directly from your project or activity?

At the moment, there are 5 families consisting of 13 adults and 9 children and approx. 12 young unaccompanied teenagers who I hope to continue to offer support to.

There are another 4 families in other parts of the county who ask for my help, and a number in other parts of the county who's needs seem to be being looked after very well, but all events that I put on, I include all refugees in the county and that is over 100.

At the last event I helped organise, 30 refugees from Newtown joined us!

There are 552 Shrewsbury and Shropshire residents in my group.

Approx. 30 active Shrewsbury based volunteers, with another 15 to come soon.

if I include people who help with events and collections there would be at least 150 active volunteers in my group.

All of these have said that they would not have known how to help without my coordination.

The combination our councils approach, of my work and refugee actions work, the good will of the public make this one of the most successful transitions I know of, so many people in Shrewsbury will benefit from a healthy and happy integration of a new sector of society. Already the arrival of these people has brought together all the churches, spiritual groups and the mosque

...The success of my projects will be measured by the attendance from all sectors of society. I will raise as much awareness of my fundraisers as I can through local media and good promotions. Any promotions material will mention all funding providers and contributors. As I said, the 13 adults. 9 children and approx. 12 teenagers in the town will directly benefit from my activities, but on a much wider scale, hundreds or thousands of people who find out about our activities will be heart warmed and enthused when they see what a big difference Shrewsbury people can make to their lives.

I intend to take educational tours of the schools, and assist the Syrians to attend and take part in awareness raising arts projects such as one that is coming to the Shrewsbury Folk Festival and help and assist them to attend the many events that take place in our town.
