CLIMATE EMERGENCY

Purpose of Report

To update members on the Climate Emergency Agenda.

Background

Below are the key milestones of Climate Emergency:

- 25th March 2019 Council declared a Climate Emergency and committed to developing an Action Plan within 6 months
- April/May The Town Clerk & Operations Manager convened a group of interested individuals
 of climate emergency and facilitated an open discussion about what the Town Council was
 already doing and what it needed to do presentation appended to this report
- July 2019 Officers undertook a review of its Carbon Footprint
- 30th September 2019 Council adopted the draft Climate Action Plan
- 27th November 2019 the Mayor convened a Mayors & Town Clerks Meeting to discuss Climate Emergency, at which Adrian Cooper the newly appointed Climate Change Task Force Leader at Shropshire Council attended
- 30th January 2020 Council set its 2020/21 budget and set aside a £250,000 fund to look at climate mitigations measures over the next three years
- 6th February 2020 Town Clerk & Deputy Town Clerk facilitated a workshop event with the Climate Change Working Group, note of which are appended to this report
- January/February 2020 Key staff have all signed into the SLCC Webinars on Climate Emergency facilitated by the Centre for Sustainable Energy.

Actions since the budget meeting

The Deputy Town Clerk has developed a set of Terms of Reference for a Climate Emergency Advisory Group and invitations to set organisations have been sent out. A number of organisations have responded and nominated a representative.

The Town Clerk has met with Adrian Cooper (Climate Change Task Force Leader) on two occasions; firstly to understand each organisation's approach to Climate Emergency and more recently areas for collaboration. These included:

- Revisiting the Hydro Scheme works
- Opportunities for solar and wind power on public estate land
- Electric Vehicle Charging Points Trials
- Procurement of Electric/Hydrogen powered vehicles
- Approach to Trees as mitigation



 STC Involvement in SC's Stakeholder Mapping Workshop designed to develop a Shropshire/Telford wide Climate Action Partnership with localised Sub-Groups

Town Council staff are continuing to work towards the Action Plan as adopted in September 2019 and ongoing work includes:

- Procurement of a solar scheme for the Quarry
- Procurement of Green Energy
- Procurement of electric hand tools for the Grounds Maintenance Team
- Exploration of Electric Vehicles for the Grounds Maintenance Fleet and the Mayor's Car
- Exploration of installation of EVCPs at Weeping Cross
- Commencement of a Buildings Audit to determine any energy efficiency measures
- Procurement of an Energy Efficient Boiler at Grange Youth Centre
- Shading work at the Greenhouse
- Expansion of the Tree Nursery at Weeping Cross
- Development of the Ash Die Back Action Plan
- Planting 2000 Trees
- Inclusion of Climate Emergency Criteria in every Tender Proposal
- Procurement in high energy efficient LED lighting for Christmas 2020

Workload

Currently COVID is taking up an extraordinary large amount of Senior Management Team time. This impacts on both the day job but also being able to work on both the Capital Programme and the Climate Emergency Agenda. Members' expectations need to be realigned to this current demand.

TERMS OF REFERENCE (Draft)

Climate Emergency Advisory Group

Membership

The Group will comprise representatives of council, climate related organisations and various community groups. Ten people will be invited from appropriate organisations to represent the community on the basis of their understanding of the climate emergency and links to the community, with consideration given to specific characteristics for representation such as age, gender and membership of targeted or general community groups.

Reports to: Finance and General Purposes Committee.

Frequency of Meetings: 4/5 per year.

Quorum: To be agreed by the Group.

Role of the group

Following the declaration of Climate Emergency Resolution on 26 March 2019, the overall purpose of this advisory group is to provide advice and support Finance and General Purposes Committee on how Shrewsbury Town Council might best proceed to reduce and measure any reduction in its (net) carbon footprint.

- The role of the group will be to advise Finance and General Purposes Committee on an appropriate Climate Emergency Action Plan for Shrewsbury Town Council.
- To represent the views and needs of relevant community organisations or community members regarding the climate emergency.
- To assist with engagement of the wider community on the agreed Climate Emergency Action Plan, including via the wider Climate Emergency group.
- To help identify high level strategic direction, opportunities, and goals that will address the climate emergency, which can be implemented practically.
- To review reports and feedback following community engagement to further inform the Climate Emergency Action Plan.
- To further inform and recommend the resources needed to meet the Council's objectives in calling a climate emergency.
