82/18 MATTERS ARISING

82.1 Reconsultation Application 17/06096/OUT – Bowbridge House

Members reconsidered the amended plans for the above application, which now includes the retention of the existing dwelling and raised no concerns.

82.2 Reconsultation Application 18/03891/FUL – 16 Granville Street

After considering the amended plans which propose a reduction in the extension, Members considered this went some way to addressing their concerns and agreed to withdraw their original objection.

RESOLVED:

That the Town Council raises no objections to this application and is happy to withdraw their original objection.

83/18 BIG TOWN PLAN

The Town Clerk circulated the final version of the Big Town Plan, which has been officially adopted by Shropshire Council and is available to the public online. This document now forms material considerations, which can be referred to when making comments on Planning Applications. The Town Clerk confirmed that this could cover windfall sites and she explained how this might work.

Councillor Dean informed Members that following the success of the first, a second 'Shrewsbury Going Forward' conference will be held on 19 January 2019. All Members should have received invitations.

Members discussed green corridors and creating green networks between development sites. They expressed their desires for developers to provide *quality* green open spaces suitable for older children to kick a football around, not just provide odd bits of land that are unsuitable for building on.

The Town Clerk agreed to create an aide memoir of the material considerations from the Big Town Plan for use by the committee when considering planning applications.

RESOLVED:

That the Town Clerk provides a handout for the committee of the material considerations from the Big Town Plan.

84/18 APPEALS

Members noted the appeals against 17/05587/FUL (land at Meole Retail Park) and 18/00641/FUL (1 Snowdrop Close) and agreed that their objectionable comments already submitted sufficed and that no further action be taken.

RESOLVED:

That the Town Council noted the appeals against applications 17/05587/FUL and 18/00641/FUL and agreed that no further action be taken.

85/18 LOCAL PLAN REVIEW

Following the presentation to Full Council by Eddie West (Senior Planner – Shropshire Council), on the Local Plan Preferred Options, and the presentation from Helen Howie (Berrys) about a development site in the Bicton Parish, the committee were asked to provide formal comments for the consultation which is due to close at the end of January. Prior to the meeting the Town Clerk circulated the maps.

Some of the proposed sites overlap into Uffington, Bicton and Great Hanwood Parish Councils. The Town Clerk has contacted each one to gather their views and their responses were read out. On these overlapping sites, the dwellers will inevitably consider themselves as Shrewsbury residents and yet will be on a different parish council's land. This would complicate the allocation of work and finances and it is feared such issues could cause tension between the Town Council and neighbouring Parish Councils. Members felt there was a need for a review of the parish boundaries to avoid this situation.

Following a discussion, Members raised the following points:

- How are the strategic objectives working and are there any missing?
- There is confusion and inconsistencies in the sustainability appraisal and how it goes from the sustainability objectives to the criteria.
- How were the plots of land allocated that rated as 'poor'?
- Members are insistent of the need to review the parish and town council boundaries
- How are windfall sites allocated? Members expect them to be small with little impact on the community and request that the local residents are consulted with as early as possible.
- Members felt 'heavy industry employment use' of site SHR166 as inappropriate for this location so close to the River. Members requested a footbridge be considered to provide access to this site.
- The allocation of the proposed open space on site SHR216 seems inappropriate if the North West Relief Road came to fruition.
- There are many concerns about the allocation of open space and question if the growth direction is right.

The Town Clerk agreed to contact the Chief Executive about the Council boundaries review and seek answers to some of these points from Eddie West ahead of the Full Council meeting.

RESOLVED:

- (i) That the Town Clerk seeks answers to the points raised and presents her findings to the Full Council meeting on 21 January 2019;
- (ii) That Full Council considers making representations to Shropshire Council regarding the potential for a review of Parish Council Boundaries.

Wood Street is already congested with parked vehicles and with no off - street parking available, this takeaway restaurant will only exacerbate the problem. The committee also considers the large, unsightly ventilation stack which will be clearly visible from the road will have a detrimental impact on the street scene.
