## SHREWSBURY BOUNCES BACK

As part of the Recovery Task Force, Shrewsbury Town Council, along with Shrewsbury Business Improvement District [BID], Shropshire Council and other partners, has been part of the activities to get the town centre back on its feet for residents and visitors over the past couple of months.

Along with supporting the temporary traffic measures put in place by Shropshire Council in order to keep people safe and help businesses to maximise their potential over the summer, the Town Council has added to the layout of the town to help create additional space for pedestrians, including planters.

Leader of Shrewsbury Town Council, Councillor Alan Mosley, said he welcomed the traffic interventions being in place until the end of September.

He added: "Removing through-traffic from



the centre of Shrewsbury during the day throughout the summer is already giving the town centre a much more welcoming atmosphere.

"This is actually a really good opportunity to test the impact of removing traffic from the town centre over an extended period, and discussions about any longer-term plans will be based on this experience and on wider local consultation.

"We are doing a lot of work with our council partners to help businesses make the most of this opportunity to use outside space creatively, which will help kick-start the local economy and bring a really welcoming and positive atmosphere to the town centre."

Town Council staff have also been working hard to re-open other assets so that they are safe and available for the public to enjoy including the Dingle, sports facilities, play areas and public toilets.



### LOCAL PLAN REVIEW – HOW TO GET INVOLVED

The pursuit of sustainable development is at the heart of the planning process.

The Shropshire Local Plan is a long-term project, covering a 22 year period from 2016 to 2038 and will ensure that the plans for the county respond to changing circumstances in line with the National Planning Policy Framework [NPPF].

The role of the Shropshire Local Plan is to ensure that the objective of sustainable development is translated into a positive framework at the local level to inform decision-making for the benefit of the county. This relates to both strategic issues, such as the amount of growth proposed and how it is distributed, and how the county moves towards a net zero carbon economy; through to more detailed issues, such as the design and layout of new developments and how environmental assets are to be protected.

Shropshire Council is now looking at updating its Local Plan with the assistance of those communities directly affected by future development and is asking local residents for their views on the best way forward for the town.

Shrewsbury is a major focus within Shropshire for the provision of infrastructure and services to meet the needs of the town and its wider catchment area, with current priorities set out in the Implementation Plan and Shrewsbury Place Plan.

Shropshire Council is consulting on a further Regulation 18 stage of the review of the Local Plan between August and September 2020. This is an important additional stage of plan consultation and has been agreed in order to allow people a chance to have their say on a full draft of the Local Plan before the council proceeds to the statutory Regulation 19 stage of plan making.
